#### Purpose:

These Terms & Conditions apply to all attendees, members, and users who take part in Lahti Entrepreneurship Society events, online platforms, community, and related services. By booking, registering, or attending, you accept the agreements found on this document.

## 2. Code of Conduct

# 4. Privacy Policy

#### What data do we collect?

Lahti Entrepreneurship Society ry stores information required by the Finnish Association Law in its membership register. This includes the member's name and domicile. In addition, Lahti Entrepreneurship Society ry stores information about:

- Personal identification information (Name, email address, phone number, address, domicile, date of birth)
- Voluntary supplementary information (Telegram username, Discord username)

We may also collect information for statistical and analytical purposes such as:

Log and data usage

## How do we collect your information?

You directly provide Lahti Entrepreneurship Society ry with most of the data we collect. We collect data and process data when you:

- Register online to be part of Lahti Entrepreneurship Society ry
- Voluntarily complete a customer survey or provide feedback on any of our message boards or via email.
- Use or view our website via your browser's cookies.
- When you register to events.

Lahti Entrepreneurship Society ry may also receive your data indirectly from the following sources:

- LTKY and KOE
- Guilds and student associations associated with LUT University and LAB University of Applied Sciences
- LUT University and LAB University of Applied Sciences
- Kide.app

#### How will we use your data?

Lahti Entrepreneurship Society ry collects your data so we can:

- Fulfill statutory obligations
- Process orders
- Facilitate member communication

If you agree, Lahti Entrepreneurship Society ry will share your data with our partner associations and companies so they may offer you their events and services

- Guilds and student associations associated with LUT University and LAB University of Applied Sciences
- LUT University and LAB University of Applied Sciences
- Kide.app

We may share your data with third-party services including:

- Kide.app
- Google Drive
- Google Analytics

#### **Data Retention**

Information from Lahti Entrepreneurship Society ry's membership register is not shared with other parties, except for the total number of registered members and association report to LTKY, which includes the number of members who are LTKY or KOE members and the number of LUT university students.

## How do we store your data?

Lahti Entrepreneurship Society ry may engage third parties to act as our service providers and perform certain tasks on our behalf, such as processing or storing data, including personal data, in connection with your use of our services.

Lahti Entrepreneurship Society ry retains personal data only for so long as necessary to fulfill the purposes for which it was collected. Once this period has expired, we will delete your data by six months.

Access to the membership register is restricted to the treasurer, chairperson and vicechairperson of Lahti Entrepreneurship Society ry. The information is stored on the association's Google Drive account. #### International data transfer

Our servers are located within the European Economic Area (EEA). If you are accessing our Services from outside the European Economic Area (EEA), please be aware that your information may be transferred to, stored, and processed by us and by those third parties with whom we may share your personal information in and other countries.

If you are a resident in the European Economic Area (EEA) or United Kingdom (UK), then these countries may not necessarily have data protection laws or other similar laws as comprehensive as those in your country. However, we will take all necessary measures to protect your personal information in accordance with this privacy notice and applicable law.

## Marketing

Lahti Entrepreneurship Society ry would like to send you information about events and jobs of ours that we think you might like, as well as those of our partner companies. The list of the companies changes by the year, but we will provide a list of them on our website and relevant noticeboards.

If you agreed to receive marketing, you may always opt out later.

You have the right at any time to stop Lahti Entrepreneurship Society ry from contacting you for marketing purposes.

## What are your data protection rights?

Lahti Entrepreneurship Society ry would like to make sure you are fully aware of all your data protection rights.

Every user is entitled to the following:

**The right to access** - You have the right to request Lahti Entrepreneurship Society ry for copies of your personal data. We may charge you a small fee for this service.

**The right to rectification** - You have the right to request that Lahti Entrepreneurship Society ry correct any information you believe is inaccurate. You also have the right to request Lahti Entrepreneurship Society ry to complete information you believe is incomplete.

**The right to erasure** - You have the right to request that Lahti Entrepreneurship Society ry erase your personal data, under certain conditions.

**The right to restrict processing** - You have the right to request that Lahti Entrepreneurship Society ry restrict the processing of your personal data, under certain conditions.

**The right to object to processing** - You have the right to object to Lahti Entrepreneurship Society ry's processing of your personal data, under certain conditions.

**The right to data portability** - You have the right to request that Lahti Entrepreneurship Society ry transfer the data that we have collected to another organization, or directly to you, under certain conditions.
